**Emergency Overview:** This material is a thick, clear, tinted acrylic topcoat. It is a stable, non-flammable, white-colored, viscous liquid with a flash point above 200°F.

## SECTION 4 – FIRST AID MEASURES

**Eye contact:** Flush eyes with clean water for 15 minutes. Seek medical attention.

**Skin contact:** Thoroughly wash with soap and warm water before the Pearl Topcoat dries. Thoroughly wash all contaminated clothing. Seek medical attention if irritation persists.

**Ingestion:** Do not induce vomiting. Seek medical attention.
